RULES

1. This tournament is open to Men & Women members of the Gillette USBC.
2. Tournament dates are December 2nd, 3rd & 4th 2016. See squad times on front of this form. Entry fee will be \$30.00 per person per event.
3. The Tournament shall consist of Men & Women. Must have one (1) of the opposite sex for team event and double event one (1) man and women. This is a closed tournament. Entries forms must be submitted by November 28, 2016 with entry fee.
4. Average: Bowler will use their highest sanctioned average with 21 games or more from end of season 2015/2016 or current average as of November 19, 2016 with 21 games. All other bowlers will bowl scratch
5. Handicap will be based on individual highest average and will be 90% of 240, with no limit on handicap pins.
6. Teams may bowled three (3) times, provided you change at least two(2) members of your team to place more than once.
7. Prize fund Pay-out: All money will be returned 100% in each event. Prize money will be divided with 80% to handicap and 20% to scratch. A bowler/team cannot cash in both the handicap and scratch divisions. A bowler/team will be place in the standings where they will get the highest payoff. The total number of entries will determine how many places will be paid in the scratch and handicap division.
 - a. Team Event: pay one (1) place for every five (5) entries.
 - b. Double Event: pay one (1) place for every ten (10) entries.
8. Substitution will be allowed in each event. Please advise the tournament director at least one-half (½) hour prior to bowling if any substitutes will be used. Only team captains are allowed to make any changes. **The lineup will remain the same as shown on the entry form unless substitution has occurred.**
9. Ties for 1st place in any event shall be decided by a one (1) game roll-off. Lanes, date and time to be determined by the tournament director.
10. A protest or appeal involving eligibility of playing rules must be filed with the tournament director in writing within fifteen (15) days of the conclusion of the tournament and the grounds for the protest or appeal briefly stated. The tournament committee shall have the power to hear and act on all protests of this tournament and/or rules. All other rules are governed by USBC.
