Gillette USBC Women's 2017/2018 Championship Tournament

RULES

1. This tournament is open to Women members of the Gillette USBC.
2. Tournament dates are February 3rd, 2018, February 5th, 2018 thru February 11th, 2018, see squad times on front of form. Entry fee will be \$30.00 per person per event. All events (optional) are \$10.00; you will be entered in scratch and handicap. All events must be paid with first entry. You may participate only once in all events using your first bowled scores in team, singles and doubles.
3. The Tournament shall consist of a four (4) women team event, a doubles event and a singles event. This is a closed tournament. Entry forms must be submitted by January 22, 2018 with entry fees.
4. Average: Bowlers will use their highest sanctioned average with 21 games or more from either 2016/2017 end of season book average or Mid-Season as of December 31, 2017 whichever is highest. All other bowlers will bowl scratch (No Ten Pin Rule).
5. Handicap will be based on individual highest average and will be 90% of 240, with no limit on handicap.
6. Singles/Doubles will be bowled concurrently during a squad time (unless prior arrangements are made due to health) with singles being bowled first. Singles and doubles may be bowled up to three (3) times each so long as your doubles event is bowled with a different partner each time. Singles/Doubles bowled on same lanes.
7. Team may bowl three (3) times, provided you change at least two (2) members of your team to place more than once.
8. Prize fund Pay Out: All money will be returned 100% in each event. Prize money will be divided with 80% to handicap and 20% to scratch. A bowler/team cannot cash in both the handicap and scratch divisions. A bowler/team will be placed in the standings where they will get the highest payoff. The total number of entries will determine how many places will be paid in the scratch division.
 - a. Team Event: pay one (1) place for every five (5) entries.
 - b. Double Event: pay one (1) place for every ten (10) entries.
 - c. Singles Event: pay one (1) place for every ten (10) entries.
 - d. All Events: pay one (1) place for every ten (10) entries.
9. Substitution will be allowed in each event. Please advise the tournament director at least one-half (1/2) hour prior to bowling if any substitutes will be used. Only team captains are allowed to make any changes. **The lineup will remain the same as shown on the entry form unless substitution has occurred.**
10. All ties will have Place monies combined and split.
11. A protest or appeal involving eligibility or playing rules must be filed with the tournament director in writing within 5 days of the conclusion of the tournament and the grounds for the protest or appeal briefly stated. The tournament committee shall have the power to hear and act on all protests of this tournament and /or rules. All other rules are governed by USBC.
